

Camp Rules

Please Read

The Wisconsin Law Enforcement Officers Association welcomes you to our campground. Please take a moment to read the following rules so all of our guests can enjoy their stays.

Because WLEOA members fund the campground, only members and their guests are allowed to camp. A WLEOA member and or their spouse must be on-site with their guest(s) at all times. For information on joining WLEOA, please visit www.wleoa.com.

The WLEOA Campground is open from Memorial Day weekend through Labor Day weekend. No reservations are necessary. Sites are available on a first-come basis. Extended stays are limited to 2 weeks in, 2 weeks out. Trailers, tents, etc. may be left at the campground for an extended period of time ONLY with the permission of a WLEOA campground committee member.

Groups are welcome to use the campground. Many members host birthday parties, anniversary parties, scouting events, etc. at the campground. Please call ahead when scheduling a large event.

Please remember to sign your name on the sign-in sheet located next to the campground restrooms when you arrive.

Pets are welcome at the campground but we ask that you keep the animal on a leash at all times, clean up any droppings immediately and not leave the animal unattended.

Please clean up after yourself. Do not leave garbage sitting out in the showers or outside where it may be blown into other campsites. Brooms and mops are provided in the showers for wiping up if dirt is tracked in.

RECYCLING IS MANDATORY

Rinse and sort recyclables. Metal & Glass/Cardboard/Paper containers for your recyclable materials are located by the dumpster near the campground entrance. Aluminum cans can be crushed and left in the container by the women's shower. Recycling and trash must be removed from your site at the end of your stay and left at the dumpster area.

The campground offers men and women's pit toilet restrooms. Men and women's shower facilities with hot and cold water are also located onsite. Water is located at various locations throughout the campground as well as at a large outdoor sink near the showers for washing dishes and other items.

Please be considerate of others. This is a facility for families. Vulgar language and behavior is not acceptable. Keep the noise down in your site, especially during the evening hours. This will help make the camping experience more enjoyable for everyone. Mandatory quiet time begins at 10 PM. If you have an offensive neighbor and cannot resolve the problem, please notify a Campground Committee Member.

Do not tamper with trees. Cut firewood is provided for your use. Please do not take more than you need.

Only a certain number of fire pits are allowed on the grounds by the regulatory authorities. Please do not dig new pits, as it only causes damage to the property and someone must work to fill it back in. Do not leave fires unattended at any time.

Discharging of fireworks is allowed only with proper permits.

We have a variety of equipment available for your use: basketballs, inner tubes, bats, balls, grills, etc. Please return this equipment to the proper place when you have finished using it. If it gets dirty, please clean it so it is in good condition for the next camper. If something gets broken, please drop a note in the donation slot on the side of the garage so the item may be repaired.

Excessive operation of off-road vehicles is prohibited. As a common sense measure, anything that causes a disturbance to others or damages campground property should be avoided.

The Wisconsin Law Enforcement Officer's Association had an early goal to establish a recreational area for use by its members and guests. As a result, in 1977 the Association purchased 30 acres of land in Waupaca County for a campground. The campground is located just outside the city of Waupaca. Located between New London and the City of Waupaca on CTH-KK, just north of South STH 54. The property includes 1,000 feet of river frontage on the south branch of the Little Wolf River.

The campground is available for use by WLEOA members and their guests. Large groups who wish to use the facility should check in advance with a campground committee member. Phone numbers are listed in the Wisconsin Law Enforcement Journal as well as on the website at www.wleoa.com. Donations are accepted from campers and/or visitors to help maintain the grounds. The WLEOA believes our campground plays an important role in the positive physical and mental development of our young people as well as providing a relaxing haven for WLEOA members and their families.

Since 1977, WLEOA members and friends have put in many hours clearing and building the campground into a facility that sees increased attendance each year. The facility includes pads for camping trailers and an area that is cleared for tent campers. Restrooms, showers, electricity and a well are all located on the grounds. A pavilion, basketball court, volleyball area, jungle gym and horseshoe pits provide recreational opportunities for campers. The Association also has bicycles available for visitors. Floatation tubes allow for an enjoyable and leisurely ride down the Little Wolf River. The campground provides a great place for an overnight stay or just a day's outing.
